## Denver Polo Club

This map and the directions below will help you find the action with ease!*

**Directions:** From Santa Fe Drive, turn west on Airport Road. Follow Airport Road for approximately .5 miles, over the bridge to Airport Road (again). Turn left on Airport Road and follow it past the large white farmhouse for approximately .25 miles. You have reached Denver Polo Club when you see the large iron gates on the left. Continue on Airport Road past the gates to the Of Horse You Can Arena and turn left.



# Show Rules

---

## Fee Schedule

- Regular Classes: \$30
- Medal Classes: \$35
- Double Derby, Jumper Relay, Gamblers: \$20
- Pro Equitation Challenge: No Entry Fee
  
- Ticketed Schooling: \$10 per ring. Available after 12:00 pm on Thursday and at conclusion of classes on Friday. Morning schooling will be held on Friday, Saturday, and Sunday mornings from 7:00 to 7:45 am (weather permitting). Morning schooling time per horse may be limited if horses are waiting.
  
- Stalls:
  - Thursday – Sunday: \$100
  - Two Consecutive Days: \$75
  - Single Day Stall: \$50
  - Minimum of four bags of shavings are required (even for day stalls)
  - Shavings are available for \$13 per bag, or you may bring your own. Please make note on stall reservation.

## **STALLS MUST BE RESERVED BY EMAIL, BY SEPTEMBER 20**

- Late Fee: \$25
- Trailer-In Facility Fee: \$40 per horse, per show
- EMT: \$15 per rider
- Office Fee: \$30 per rider
  
- All checks made payable to Colorado Show Circuit
- Checks, Venmo, and PayPal are accepted. Credit cards are not accepted.
- Returned checks must be paid in cash or by cashiers check within 30 days of notification plus a \$50 fee.
- Non-showing horses must pay office, EMT, and stall/trailer-in fees.

# Competition Rules



-Back to back rounds are allowed and encouraged.

-No-judge rounds will be allowed as long as time permits.

If in a division in which the horse is competing, the judged round will be the first round. No-judge rounds are permitted after the first round.

-Helmets must be worn at all times while mounted on competition grounds.

-Numbers must be worn at all times while mounted.

-Competition management has the right to cancel, combine or divide any class(es), should it be in the best interest of the show.

**-Management may move classes to a different ring at any time deemed necessary.**

-Only one horse per entry.

-Pets must be kept on a leash at all times

-Champion and Reserve will be offered in all divisions.

-First place recipients (all divisions) will choose from the prize table.

# Special Classes



**Gamblers' Choice:** Jumps will be assigned a value on the course chart, riders will have 60 seconds from crossing the start markers to get as many points as possible. Jumps may only be jumped twice. All jumps may be jumped in either direction. If a jump comes down it may not be attempted again. At 60 seconds a buzzer will sound and riders must get to the finish timer line. The points for the last jump will only count if the horse has left the ground when the buzzer sounds. Class will be ranked by the most points, in the case of equal points ties will be broken by the time. Fences to be 1.0m. The joker fence will be 1.10m and riders will have 45 seconds to make an attempt at it. A rail or refusal will result in -200 points, clearing the fence will add 200 points to the score. Prizes are ribbons and \$100 to winner, \$50 to second place.

**Pro Equitation Challenge:** No entry fee. This class is restricted to professionals. It will be held in the hunter ring and judged by two judges. Scores will be a combination of a general equitation score and a bonus 1 – 10 score based on the most creative, well executed equitation course. Some oxers may only be jumped a certain direction and riders will be responsible for adhering to this. Courses are to be 8 – 12 fences, penalties will be assessed for too many or too few fences.

Every entry at a recognized competition shall constitute an agreement and affirmation that all participants (which include, without limitation, the owner, lessee, trainer, manager, agent, coach, driver, rider, handler and the horse), For themselves, their principles, representatives, employees and agents: (1) Shall be subject to the constitution and rules of CSC, CHJA, and DPC and the local rules of the competition; (2) Represent that every horse, rider, driver, and handler is eligible as entered; (3) Agree to be bound by the constitution and rules of CSC, CHJA, and DPC and of the competition, and will accept as final the decision of CSC, DPC on any question arising under said rules, and agree to hold the competition, DPC their officials, directors and employees harmless for any action taken; (4) Agree that as a condition of and in consideration of acceptance of entry, they authorize CSC, CHJA, DPC and/or the competition management to market, transfer, assign or otherwise make any use of any photographs, likenesses, films, broadcast, cablecasts, audiotapes, or videotapes taken of the horses(s) and participant(s) while on the grounds, incident to, on in transit between the stabling facility and the event site, in any way they see fit for the promotion, coverage or benefit of the event, sport, CSC, CHJA, or DPC, without compensation to any of them, so long as the use neither jeopardizes amateur state nor endorses a specific product or service, and hereby expressly and irrevocably waive and release any rights in connection with such, including any claim to invasion of privacy, right of publicity, or to misappropriation; and (5) Agree that they participate voluntarily in the competition fully aware that horse sports and the competition involve inherent dangerous risk of serious injury or death, and by participating they expressly assume any and all risks of injury or loss, and they agree to hold CSC, CHJA, DPC, the competition and their officials, directors, employees and agent harmless from and against all claims including claims based on negligence, breach of contract, strict liability and/or otherwise for any injury or loss suffered during or in connection with the competition, officials, directors, employees or agents of CSC, CHJA, DPC or competition. The construction and application of CSC, CHJA, and DPC rules are governed by the laws of the State of Colorado, and any action instituted against CSC and/or CHJA and/or DPC must be filed in the State of Colorado.
