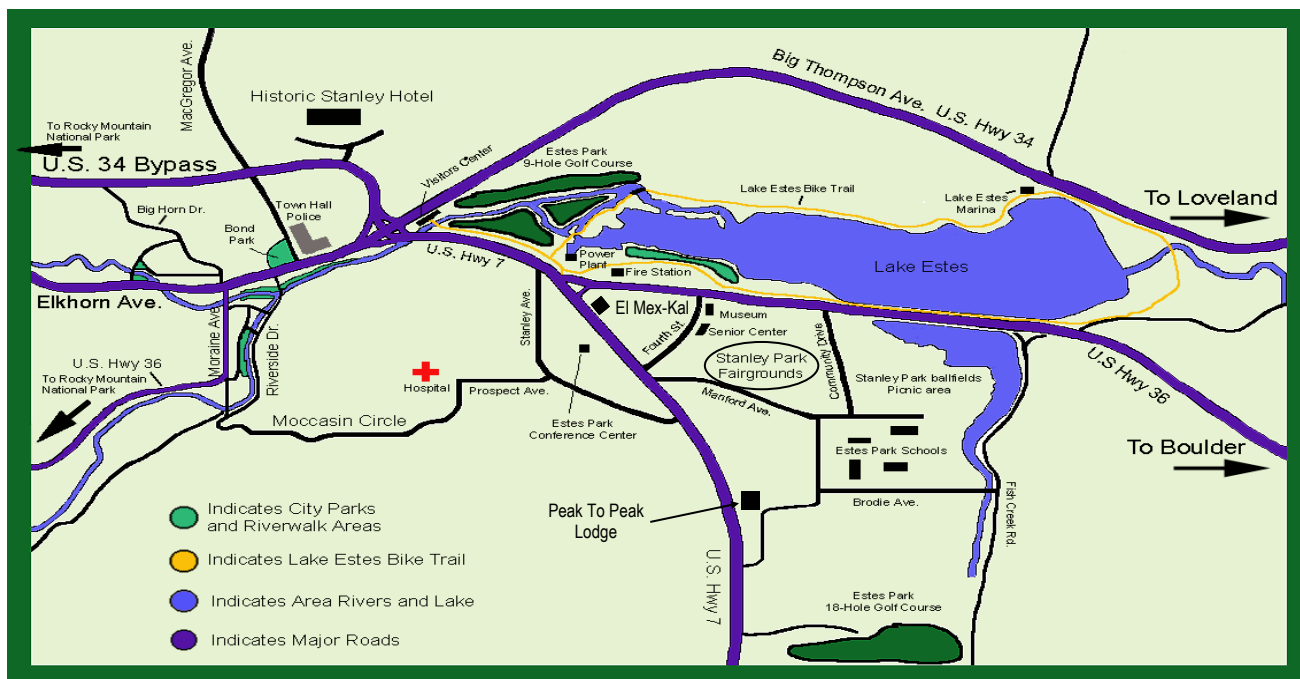

ESTES PARK FESTIVAL HORSE SHOWS ** RULES & REGULATIONS

ENTRY PROCEDURES:

- a) For each entry, regardless of how you plan to settle your account at the end of the show, you must complete the credit card section on the entry blank, but no money will be charged before the show. At the end of the show, your credit card listed will be charged the full amount due on your account, plus a 3% Convenience Fee. If you would rather pay by check, you must bring an open and signed check to the office by noon on the day you are showing and your check will be used to pay your account. If you don't bring a check by the time listed, your credit card will be used to settle your account.
- b) Because of new health requirements, entry blanks MUST be submitted with ALL the information completely listed and ALL signatures in place. Class numbers may be added upon arrival to the show.
- c) USEF, USHJA, ASPCA, CHJA and various other organizations have specific requirements for entry and participation in certain or all classes at this competition. Proof of membership for owners, riders and trainers, USEF horse recording numbers are among the items that sanctioning organizations require. Competitors are responsible for knowledge of the requisite rules and for providing the required data. Non-member / show pass and other fees may be assessed if these items are not available. Competitors may be refused entry into certain classes if required data is not provided.

REGISTRATION / LATE FEE: Entries are not required to pay a Registration Fee in advance and there is no Late Fee. Every horse must pay a \$50 Registration Fee that will be charged at the time of close-out. .

STABLING / GROUNDS FEE: Stalls for the full week or for horses arriving prior to Friday are \$250. Weekend stalls (Friday to Sunday only) will be \$125. A Grounds Fee of \$25 per day will be charged for horses showing which have not purchased a stall. Day stalls are \$75 per day.

ADDING CLASSES: If you wish to add a class after initially checking in and picking up your number, you must do so prior to the start of the class. You may do so by either filling out an Add / Scratch Form from the office or by notifying the starter at the back gate. There is no charge to add a class.

SCRATCHING CLASSES: If you do not intend to show in a class you have entered, you MUST scratch it prior to the start of the class. You may do so by either filling out an Add / Scratch Form in the office or by notifying the starter at the back gate. There will be no charge for this. Scratches may not be done after a class has started.

MEDIC FEE: Every entry will be charged a \$25 Medic Fee PER SHOW.

SHOW SCRATCH (a horse entered but scratched from the entire show prior to going in any classes): All fees shall be refunded except for a stall fee if the horse used a stall for any part of the week. All show scratches must be submitted in writing before the end of the show. No refunds will be considered after the end of the show.

EQUITATION ENTRIES: Equitation riders must wear the number of the horse they are entered on. Numbers are assigned to horses, not riders. If a rider wishes to change horses for an equitation class, they may do so without penalty; however, the proper paperwork must be completed in the show office prior to the start of the class. Exhibitors changing horses without notifying the office will forfeit their entry fee on the original horse and be charged the entry fee plus an RDNE Fee on the new horse.

SUBSTITUTIONS: With a vet's certificate, a new horse may be substituted for a show scratched horse as long as the scratched horse has not shown in any classes and both horses are registered under the same trainer. The scratched horse's Registration Fee and stall fee are transferred to the substituted horse with no penalty or charge.

RETURNED CHECKS: Checks returned by the bank for any reason are regarded as a most serious offense. A 10% PENALTY WILL BE ASSESSED FOR EVERY RETURNED CHECK (MINIMUM OF \$50.00)! Accounts will be given seven (7) days to be paid in full with cash or cash equivalent or they will be turned into the USEF for disciplinary action.

RDNE (Rode Did Not Enter): Entries that show in a class not properly entered will be charged the class entry fee plus a \$25.00 RDNE Fee. Starters are not responsible for keeping you out of classes that you are not officially entered in. Trainers and competitors are encouraged to stop by the office every day and print out their schedule of horses and classes to confirm their entries.

HEALTH REQUIREMENTS: Horses entering Colorado must have a Certificate of Veterinary Inspection (CVI) within 30 days and Negative EIA

Test within 12 months. Please consult the Colorado Department of Agriculture's State Veterinarian's Office at 303-239-4161 for additional or updated requirements.

DOGS: Dogs are not permitted to be loose on competition grounds and must be on a leash or otherwise contained. Individuals must not lead dogs on a leash while mounted. Dog owners are solely responsible for any damages, claims, losses or actions resulting from their dogs' behaviors. Dog owners failing to comply with this rule may be subject to penalty under Chapters 6 and 7, as well as issuance of warning cards pursuant to rule GR 301. In addition, pursuant to facility regulations, loose dogs will be removed by animal control from the show grounds at the owner's expense.

ARENAS - Ring 1 is 270'x150'; Ring 1 Warm-up is 200'x75'; all rings have sand mix footing.

MEDICAL WASTE: Sharps must be placed in the proper receptacles. Anyone found in violation shall be subject to a \$50 fine per occurrence.

SHAVINGS: Local laws will supersede USEF GR1216.7. Competitors are prohibited from bringing their own shavings onto fairgrounds property for either personal or commercial use. Shavings must be purchased through the feed and bedding concession on the grounds. Violations will result in a \$5 per bag or \$50 per stall surcharge added to the trainer account.

PROTECTIVE HEADGEAR: All exhibitors are required to wear properly fastened protective headgear which meets or exceeds ASTM/SEI standards while jumping anywhere on the competition grounds. It must be properly fitted with harness secured. Except as may otherwise be mandated by local law, all juniors riding in Hunter, Jumper and Hunter Seat Equitation sections must wear properly fitted headgear. Any rider violating this rule at any time must immediately be prohibited from further riding until such headgear is properly in place.

OPERATION OF MOTORIZED VEHICLES: Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind including, but limited to, golf carts, motorcycles, scooters, or farm utility vehicles on the competition grounds of recognized competitions. Minors who have a valid temporary license may operate the above described vehicles so long as they are accompanied by an adult with a valid driver's license. The parent(s), legal guardian(s), or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for sanctions against the parent(s), guardian(s), and/or trainer(s) who are responsible for the child committing the offense. Penalties may include exclusion of the child, parent(s), guardian(s), and/or trainer(s) from the competition grounds for the remainder of the competition and charges being filed against any of the above individuals in accordance with Chapter 6. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

USEF RULE GR901.11: The horse show policies stated herein regarding scratches and refunds will be followed regardless of weather and in place of USEF Rule GR901.11.

USEF MEMBERSHIP STATEMENT

(Updated 2020)

Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A non-member may participate as a handler, rider, driver, owner, lessee, agent, coach or trainer at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a \$45 Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot (exception: Friesian performance FR218) and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) NRHA Endorsed Reining Competitions. 8) Opportunity classes, 9) citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation, 10) USEA beginner novice division; and 11) assistant handlers in Dressage Sport Horse Breeding classes.

FEDERATION ENTRY AGREEMENT

By entering a Federation-licensed Competition and signing this entry blank as the Owner, Lessee, Trainer, Manager, Agent, Coach, Driver, Rider, Handler, Vaultor or Longeur and on behalf of myself and my principals, representatives, employees and agents, I agree that I am subject to the Bylaws and Rules of The United States Equestrian Federation, Inc. (the "Federation") and the local rules of the competition. I agree to be bound by the Bylaws and Rules of the Federation and of the competition. I will accept as final the decision of the Hearing Committee on any question arising under the Rules, and agree to release and hold harmless the competition, the Federation, their officials, directors and employees for any action taken under the Rules. I represent that I am eligible to enter and/or participate under the Rules, and every horse I am entering is eligible as entered. I also agree that as a condition of and in consideration of acceptance of entry, the Federation and/or the Competition may use or assign photographs, videos, audios, cablecasts, broadcasts, internet, film, new media or other likenesses of me and my horse taken during the course of the competition for the promotion, coverage or benefit of the competition, sport, or the Federation. Those likenesses shall not be used to advertise a product and they may not be used in such a way as to jeopardize amateur status. I hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity, or to misappropriation. The construction and application of Federation rules are governed by the laws of the State of New York, and any action instituted against the Federation must be filed in New York State. See GR908.4.

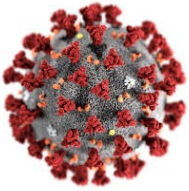
STATEMENT AS TO FEDERATION FEE (GR208.1)

For every horse participating in any competition licensed by the Federation, a \$23 Federation fee will be collected (\$15 shall be an Equine Drugs and Medication fee to provide for research, inspection, and enforcement of rules regarding use of medications and drugs; see GR407.1, .2 and .3). Exception: Horses entered in classes exempted from the Equine Drugs and Medication fee are also exempt from the balance of the Federation fee

CURRENT IMPORTANT COVID-19 INFORMATION (as of May 30th, 2020)

The following are some of the current requirements and procedures, as of today, that will be followed during the shows. **This is subject to change** as requirements from the CDC, State and County health officials are updated. These updates will be available on the CEP website at www.cepshows.com and upon your arrival.

- Each stable attending should be diligent to make sure everyone coming is not ill and has no symptoms, brings and uses the proper personal protective equipment they feel necessary and practices proper social distancing and hand washing / sanitizing procedures to stay as safe as possible.
- All trainers are responsible for every person in their barn, including riders, owners, staff, grooms, family members and friends and must take their temperature using a non-contact infrared thermometer each day upon arrival and keep a written record of each person's name, arrival time and temperature. A form that you can use will be available on the CEP website soon. This record must be presented to the horse show office at the end of each week on Sunday afternoon ... you may retain a copy if you wish. As per the CDC, people are considered to have a fever if their temperature is 100.4 degrees or higher. Any person that scans a temperature of 100.4 degrees or higher must immediately leave the grounds and contact their doctor for further treatment. If anyone has a fever of 100.4 degrees or higher, the trainer must immediately notify the horse show.
- Each stable is considered a family and will be provided stabling in blocks of stalls. This makes it critical that trainers submit a Block Stabling Request in a timely manner listing everyone in their barn to be stabled together.
- ALL ENTRIES MUST BE MAILED IN OR DONE ONLINE - NO EXCEPTIONS ... you may not walk into the horse show office and fill out an entry blank ... mailed entries must be postmarked by Monday, June 29th and received within seven (7) days. After June 29th, you must submit entries electronically, no exceptions!
- Each stable should designate a representative to handle all accounts with the show secretary and make every effort to only have this representative conducting business in the office. If that one person is not available to go to the office when needed, then another individual may take their place, but the idea is to have as few different people as possible going into the office.
- Management reserves the right to limit the number of persons in the horse show office at any given time ... such limitations will be posted on the door and those waiting outside to conduct business must do so by practicing proper social distancing from others that may be waiting as well.
- Management mandates that only essential people accompany horses to the warm-up area and the back gate ... this could include the trainer, a groom and one family member. All others should go directly from the barn to the show ring to watch their family member or barn mate compete while practicing social distancing.
- Proper social distancing, both among people and horses, in the stabling areas, warm-up rings, back gates and seating / viewing areas must be exercised at all times ... horse show staff have full authority to ask groups to disperse if necessary.
- Take a picture of your course and watch some trips before you school to reduce traffic and time spent at the gate and course board.
- Be sure to bring your own water as water cups and dispensers will not be available at the back gates.
- All horse show staff will be wearing masks ... all others are required, by USEF rule, to do so as well. Masks are optional while mounted and will not be penalized by judges if worn in the show ring. Please keep in mind that the wearing of masks by competitors is mandatory per USEF rules.

Updates, changes and additions to this list and further information will be published on the CEP website as it becomes available from the CDC, State and County health officials. Please check it often. Trainers must review the latest procedures and precautions related to CEP's Covid-19 Plan with their clients prior to arrival to the show, are responsible for their clients actions during the show and must understand that repeated issues may result in their clients being excused from the show and removed from the grounds. I understand and agree that by entering this Competition, I am subject to Federation Rules, the Prize List, and local rules of the competition. I agree to waive the right to the use of my photos at the competition, and agree that any actions against the Federation must be brought in New York State.

Release, Assumption of Risk, Waiver and Indemnification
 This document waives important legal rights. Read it carefully before signing. I AGREE in consideration for my participation in this Competition to the following: I AGREE that the "Federation" and "Competition" as used above includes all of their officials, officers, directors, employees, agents, personnel volunteers and affiliated organizations. I AGREE that I choose to participate voluntarily in the Competition with my horse, as a rider, driver, handler, valet, longeur, lessee, owner, agent, coach, trainer, or as parent or guardian of a junior exhibitor. I am fully aware and acknowledge that horse sports and the Competition involve inherent dangerous risks of accident, loss, and serious bodily injury including broken bones, head injuries, trauma, pain, suffering or death ("Harm"). I AGREE to hold harmless and release the Federation and the Competition from all claims for money damages or otherwise for any Harm to me or my horse and for any Harm of any nature caused by me or my horse to others, even if the Harm arises or results, directly or indirectly, from the negligence of the Federation or the Competition.
